I authorize the undersigned Producer to make use of my appearance on:

____ I understand that I am to receive no compensation for this appearance,

And agree that the Producer shall have complete ownership of the program. I give the Producer the right to use my name, likeness and biographical material to publicize the program and the services of the Producer. I further understand the master tape remains the property of the Producer and that there will be no restrictions on the number of times that my name and likeness may be used.

Furthermore:

I consent to the use of my name, voice, image, likeness, and any and all attributes of my personality, in, on or in connection with any film, audio tape, video tape, audio-visual work, photograph, illustration, animation, or broadcast, in any media or embodiment, now known or unknown, including, without limitation, all formats of computer readable media, produced by or for the benefit of the Producer.

I further consent to the use of my name, voice, image, likeness, and any and all attributes of my personality in any advertising or promotional material created or used in connection with the Program and Producer and each such item of advertising or promotional material will be considered a "Work" for purposes of this agreement. I acknowledge and agree that the Work (the products and results of the services to be rendered by me) is a work made for hire and I agree that the Work (and all rights therein, including, without limitation, copyright) belongs to and shall be the sole and exclusive property of the Producer.

If for any reason the Work would not be considered a work made for hire under applicable law, I hereby irrevocably sell, assign, and transfer to Producer, its successors and assigns (a) any and all claims of entire right, title and interest in and to the copyright in the Program and the Producer, (b) the exclusive and perpetual right throughout the world to use, print, produce, publish, copy, display, perform, exhibit, transmit, broadcast, disseminate, market, advertise, sell, lease, license, transfer, modify, and create derivative works from the Program in any media or format, now known or unknown, for any purpose whatsoever.

I waive any right to inspect, examine or approve the content of the Program.

I agree that the Producer will have no obligation to utilize the authorizations and rights I grant to the Producer hereunder.

I hereby release, discharge, and agree to hold harmless the Producer, its legal representatives and assigns, all persons acting under its authority, and those for whom it is acting, from all claims, causes of action and liability of any kind, now known or unknown, in law or in equity, based upon or arising out of the Program or this agreement including, without limitation, claims of libel, slander, invasion of privacy, right of publicity, defamation, trademark infringement, and copyright infringement.

I represent and warrant that I am over the age of eighteen (18) years, and have the right to contract in my own name. I further affirm that the authorizations and rights granted hereunder do not conflict with or violate the rights of any third party. If I am under the age of eighteen (18) years, my legal parents/guardians have to right to contract in my name.

I have read the above authorization, release and agreement, prior to its execution; I fully understand the contents thereof. This agreement will be binding upon my heirs, successors, representatives, and assigns.
